Notice to Exhibitors

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of AAC rules and regulations including, but not limited to, the following:

This event will be held in accordance with the rules and regulations of the Agility Association of Canada (AAC). The obstacles shall be chosen from those described in the current edition of the *AAC Official Rules and Regulations* and shall conform to AAC specifications.

All breeds and mixed breeds eighteen months of age and older (no exceptions) are eligible to compete. Blind, lame, or aggressive dogs are ineligible as are bitches in season, or dogs suffering from any deformity, injury, or illness that may affect the dog's physical or mental performance (judge's discretion).

All dogs must have an AAC Registration Number before their entries will be accepted in an AAC sanctioned trial. The registration form is available at www.aac.ca, General Information, Official Forms. Dogs with numbers pending will not be eligible to compete.

No toys, food, or other training devices shall be allowed on the course.

All dogs must be **under control** (i.e. penned, crated, or leashed) when not in the ring. Please take responsibility for your dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or engage in unsafe or disruptive behaviour may be asked by the Trial Committee to leave the trial site. There will be no refunds for entries if the dog or handler is *dismissed* from the competition for any reason.

All exhibitors entering this trial are required to work as a volunteer. A workers volunteer schedule will be posted on Saturday and Sunday mornings. Please check the volunteer sheet to see what positions you have been assigned for each day and if there are any conflicts with it and your running order please let the Trial Chair know.

Please take note of the SPECIAL TRIAL PACKAGE price. If you enter ALL classes for BOTH days, your entry fee per dog is \$100.00.

Have fun, run safe and run clean!

ENTRIES

- True North Agility (TNA) reserves the right to refuse any entry.
- Anyone not in good standing with AAC will not be allowed to enter the trial.
- Cheques in CDN funds only are made payable to Lorna MacKinley and dated no later than the closing date.
- Refunds will not be given for cancellations after the closing date except for bitches in season or injury to a dog (veterinarian certificate required), or handler, which physically prevents them from competing. Refunds requested for any other reason will be handled on a case-by-case basis and will be at the discretion of True North Agility.
- By AAC rules, entries are not valid until payment of entry fees has been received or confirmed.

AAC CLASS DESCRIPTIONS

Starters: Open to dogs that have not earned a Starters title.

Advanced: Open to dogs that have not earned an Advanced title.

Masters: Open to dogs that have earned an Advanced title.

Regular: Dogs will jump standard heights and course times as set by AAC rules.

Specials: Open to all dogs. Course times and jump heights will be as per AAC rules. Please check with the AAC for the rule change that permits a "one time" move between Specials and Regular divisions. Dogs may move from the Specials division to the Veterans division.

Veterans: For dogs 7 years of age or older in the case of dogs who have been competing in Regular classes; for dogs 5 years of age or older who have been competing in the Specials division for a minimum of one year. Once a dog has entered an official trial in the Veterans division, they may no longer compete in the Regular or Specials divisions. Course times and jump heights will be as per AAC rules.

PRIZES

- All classes will receive flat ribbons for 1st, 2nd, 3rd, and 4th.

OBSTACLE FAMILIARIZATION / WARM-UP AREA

- There will be no obstacle familiarization.
- A warm-up area will be provided as required by AAC rules. The warm-up area is for the use of dogs that are about to run.
