The Moncton Kennel Club is offering Early Bird Entry. This means that to take advantage of this offer your entry must be in the hands of the Trial Secretary no later than 10 p.m. Wednesday, September 04th 2019 entries arriving later will be required to pay the Regular Entry Fee.

ENTRY FEES

The Entry Fees may be paid by Cheque, Money Order or Cash. All cheques and/or money orders must be made payable to “THE MONCTON KENNEL CLUB”

Listing Fees are payable with the entry for dogs that do not have their individual CKC Registration Number, or CKC Event Registration Number (ERN) **Official CKC Entry Forms MUST be used.**

No post dated cheques will be accepted. A post dated cheque is one that is dated after the receipt of the entry. **All N.S.F. cheques will be subject to a charge of \$25.00.** N.S.F. cheques are considered non-payment of entry fee and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show.

Attention USA Exhibitors: Please note that due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, **however**, they are to be payable in Canadian Funds. If you send a cheque in US Funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques “Payable In Canadian Funds” or “At Par”, they will NOT be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You!

NON-MEMBER PARTICIPATION FEE

A non-member participation fee will be charged to a resident of Canada who is a “non member” of the Canadian Kennel Club. The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non member residents of Canada and is not applicable to Canadian Kennel Club member

REFUND INFORMATION

Entry Fees will be refunded for bitches that come into season after the closing date. Entry fees will also be refunded for dogs/bitches that pose a threat of communicable diseases on the day of the trial. To obtain either of these refunds a letter from a Veterinarian must be presented to the Trial Secretary prior to the commencement of the trial.

VOLUNTEER ASSISTANCE

To make this event a success, volunteering is a must. Please indicate your preferred job on the Entry Form and we will do our best to accommodate your request. Thank you in advance.

ELIGIBILITY

In order to be eligible to compete in these Trials, a dog must be registered with the CKC and have a CKC Registration Number, an ERN, PEN, CCN or Misc Certification Number, or be eligible for the same. Dogs may be spayed or neutered and/or debarked. Dogs must be 18 months of age or older. Dogs may not be lame. These Agility Trials will be held indoors at the For the Love of Dog K9 Event Centre, New Dominion PE. The surface is Turf. The precincts of these trials will be the ring and 10 feet surrounding it.

NOTE:

MKC accepts entries for dogs that have a CCN (Canine Companion Number) issued by the CKC

MOVE UPS

DAY OF EVENT ENTRIES

The MKC will accept Day of Event entries for Trials 2, 3, 4 & 5 ONLY. These entries must be made at least one hour before the trial for which they are applying.

DIRECTIONS TO EVENT

1638 Route #19 New Dominion

- When you come across the Confederation Bridge, ignore your GPS ! Stay on the Trans Canada Hwy and follow the sign for Charlottetown
- 30 min down the Hwy is Cornwall. At the stoplights in Cornwall (Tim Horton's, Pizza Delight, Subway etc) turn RIGHT onto Meadowbank Rd. (now you can turn on your GPS!)
- Come all the way down Meadowbank, over the West River Bridge, travel about another 1.5km past the bridge until you see the turnoff for Rocky Point.
- Turn LEFT onto Route #19 (to Rocky Point) (if you go past the Gass' gas station, you've missed the turn off.)
- Come down Route #19 until the fork in the road – The Afton Community Hall is on your right.
- Stay LEFT on Route #19 (do not take the right at the Afton Hall/Nine Mile Creek rd)
- My driveway is about 6 driveways down on the RIGHT from the fork in the road.

GENERAL INFORMATION

- 1 Dogs should be ready to run when called. We would like to keep the Trial running smoothly. Please advise the Trial Secretary if you have an absent dog.
- 2 Exhibitors must abide by any errors made when entering their dog(s), regardless of how or who made the errors. PLEASE PRINT OR TYPE YOUR ENTRY CLEARLY AND PLEASE CHECK IT BEFORE PUTTING IT IN THE MAIL. IF FAXING YOUR ENTRY PLEASE WRITE WITH A BLACK PEN.
- 3 The committee reserves the right to refuse any entry, subject to CKC rules.
- 4 The Trial Superintendent will be in full charge of these events, which are governed by CKC rules.
- 5 Any dog not entered in the Agility Trials will NOT be allowed within the precincts of the event.
- 6 The Trial Committee will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune to dogs, exhibitors or patrons. The Moncton Kennel Club will NOT be responsible for any equipment left behind.
- 7 It shall be the duty and obligation of the trial-giving Club to see that a Judge, club official, volunteer, or participant of any event held under these rules is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report, indicating that this has occurred.
