**Fun Match Information/Guidelines:**

1. Some crating space is available inside horse stalls (that haven't been used for years) or from your car.
2. Toys or food will be allowed in the ring. No throwing of food or toys.
3. All dogs must be under control (i.e. penned, crated, or leashed) when not in the ring.
4. There will be an area to bring chairs and watch the trial. Spectators are welcome.
5. Only dogs running, on deck, and warming up will be allowed in the arena.
6. Please pick up after your dog.
7. Please bring your own water. Viewing area in kitchen available (microwave, fridge, kettle available).
8. Washroom available.
9. ONLY dogs registered will be allowed in the barn. Spectators are welcome to watch without dogs.
10. Courses will be emailed prior to the fun match and one copy posted in the barn. Volunteer grid and running orders will also be emailed and posted in the barn.
11. Volunteer List: Submission of your entry to this trial indicates agreement to perform working positions for the fun match. Volunteer grid will be posted prior to fun match.

**PAYMENTS:** Only E-transfers will be accepted as payment for the fun match.

Take left on Greenhouse Road (at M&K Millwork sign) – follow until the end to the Barn
